They are trying to do more fundraisers to bring more money in. The board has asked the Council for ideas on what should be done with the house. They will be applying for local grants to help with the repairs and maintenance that is needed.

Bob Meyer of RJ Meyer and Associates Accounting presented the City with a copy of the audit for budget year 2013 – 2014. Meyer reviewed the audit with the Council and responded to various Council questions for discussion. A motion was made by Council member Reichman, second of Council member Johnson to pay the Sewer Land Loan of \$285,000 plus the interest accrued with the City's Pyle CD through Adams Bank and Trust when the CD matures April 9, 2015. Clerk Jepsen stated that the water department will be working on painting the well houses throughout the summer.

Council member Graeff said there is an opening on the Housing Authority Board and the nominees should be placed on the next agenda.

Council member Johnson mentioned that the Sheriff's office has been receiving multiple complaints on barking dogs and unlicensed dogs. The city office has been working on a letter that will mailed out to all those who have or may have dogs reminding them to get them licensed.
